
# First Street North

# COMING

First Street North Residences will consist of 2 six-story buildings and will have a total of 165 Low-Income Housing Tax Credit (LIHTC) units and 83 referral based units located in Little Tokyo. It will consist of a mix of unit sizes ranging from studios to 3 bedroom units for households earning 30% to 80% of the Area Median Income (AMI) for the County of Los Angeles. Minimum income is set at 1.5x the rent.



First Street North Residences is managed by Trillium Property Management.

All units will come with an electric stove and refrigerator, central a/c and heat, access to on-site laundry, resident-only courtyards, on-site property management and supportive services offices.

Accessible units include features such as bathtubs with grabs bars and shower seats as well as grab bars near the toilet. They also include lowered kitchen cabinets, wheelchair accessible kitchen and bathroom sinks, and sensory smoke/carbon monoxide detectors with flashing lights.

Pre-Applications for the lottery will be available 12/15/2025 - 01/31/2026.
