Kalmia Rose consists of 76 apartment homes of which 61 are affordable to families earning between 30%-60% AMI (39 of these are reserved for existing Jordan Downs public housing residents). There is one staff unit and the remaining 14 apartments are market-rate. Kalmia Rose is located one block from a new transit stop at the Jordan Downs Plaza retail center on Century Blvd. and is in close proximity to a medical clinic, pharmacy, high school and library.

All applications must be submitted by 3/8/2024 at 5pm (postmark dates will not be considered).
